

# BAHAMAS SWIMMING FEDERATION 2012 PRESIDENT'S REPORT

#### 2009 Elections

The current Executive Team was elected unopposed in 2009 – this team includes Algernon Cargill, President, John Bradley, First Vice President, Sheena Deveaux, Second Vice President, Kathy Dillette, Secretary General, Val Lowe, Assistant Secretary, and Ken Bain, Treasurer. This team has been focused on expanding the reach of the Federation globally through direct linkages with CCCAN and the Bahamas Olympic Associated and in this regard, Algernon Cargill was elected as the Vice President of the English Caribbean for CCCAN and also as a Vice President of The Bahamas Olympic Association. These positions have brought considerable benefits to the Federation and have also positioned The Bahamas as a significant voice in Regional and Global Aquatic Sports.

Our focus remains to promote a swimmer friendly Federation and to increase the profile and results of Aquatics in The Bahamas through a sharp focus on ensuring that every person who wants to maximize their potential in swimming or water polo has a positive and swimmer friendly Federation that supports this dream. A key phrase adopted in 2003 that is still a widely held belief: *Swimmers/Athletes first, Federation Second, and Parents Third!* continues to be the mantra of the Federation's executives.

The relationships we have developed with Corporate Bahamas and the Government of the Bahamas position us as a productive and focused Federation that is highly respected locally and globally. The team, though small, has done an excellent job and I thank them on behalf of the entire Federation for their commitment over the past 3 years.

#### BSF Rule Book. Athlete Policy and Constitutional Proposals

Over the past few years, we have made significant enhancements to the BSF Rules and Regulations, all geared towards ensuring that the Federation understands the focus should be on what is best for the athletes, and how can we ensure that the Federation's goals are aligned with that of its members. We have been able to remove many of the punitive rules that sought to punish instead of reward athletes and teams and the major rule passed at the last Constitutional Meeting was the extension of the Executive Term from 2 to 3 years. Similar to the Bahamas Olympic Association, and consistent with the Olympic movement, consideration should be given to extending the term to 4 years to ensure that the focus will remain the same during an Olympic quadrennial.

The rules proposed this year are attached to this report for review and discussion by the members.

The Athletes Policy adopted in 2006 streamlined the National Team selection process, the requirement to represent the Bahamas at the International level for subvented athletes, and the additional requirements for all subvented athletes and those intending to represent The Bahamas internationally, to participate in the National Championships. This policy together with the objective input of the Federation Executives is used as a base for continuing recommendations for subventions and team positions. A similar policy is being adopted by the Bahamas Government for athletes receiving Government subventions as there has been a trend in other Federations for subvented athletes to opt out of participating in some regional and even international competitions. We continue to strictly enforce this policy and overall, the support from the Federation and athletes has not resulted in any unfavourable recommendations/actions over the past three year period.

#### **Focus**

The current local economic conditions continue to affect our fundraising, and throughout the past three years, our major sponsors have continued to support the Federation. Without question, the largest sponsor is the Government of The Bahamas who has provided an airplane for the CARIFTA Team to travel every CARIFTA, and also provides the Federation with an Annual Grant and this year, increased the subvention of our athletes from 1 in 2003 to 10 in 2012. This is excellent!

Royal Bank also pledged its increased support for our National Championships this year and truly exemplifies the actions of a model Corporate Citizen. We are grateful for RBC's continued and uninterrupted support and are pleased to advise that this support is already pledged for 2013 – largely because of our relationship and secondly, because of the visible quality of the work the Federation displays. Royal Bank continues to also support our Academic Bahamian Swimmer Awards and this opportunity enables our swimmers to demonstrate that they are not only model athletes, but excellent students.

Cable Bahamas continues to broadcast our National Championships at no cost to the Federation and the Royal Bank of Canada has committed to continuing sponsorship of our National Swimming Championships and we this exposure has brought a national focus on swimming as our National Championships remain the only event that is broadcast live on Cable's network.

The challenge developing is the National Sports Authority and the decreased availability of the Betty Kelly-Kenning Aquatic Center. Simply put, this policy has not been beneficial to the Federation as the increased administration and proposed costs to use the BKKAC even for local meets is having an adverse effect on our Federation. Our team has

had several meetings with the Sports Authority Executives and will extend these meetings to the Government unless we can work out a favourable win/win situation for all clubs. The downside for the Federation has been that the equipment at the BKKAC was not being satisfactorily maintained, the heaters were not functioning properly, and now that they are, have not been turned on by the NSA, and the facility does not appear to be satisfactorily maintained and/or cleaned regularly. On behalf of the Federation, I must recognize the contributions of David Morley in networking with the NSA and the Government of The Bahamas in not only readying the facilities for CARIFTA 2012, but serving as our representative on the NSA and fronting all communications with the key stakeholders about the facility.

The water polo team continues to grow, and prior to 2007, we were not seeing any real growth in this program, Coach Lotty has demonstrated his commitment to reviving the program and his efforts are commendable. I challenge him to reintroduce a female water polo team and to maintain his focus on ensuring that the Bahamas is represented at Regional Championships.

SWIFT Swimming is commended for its introduction of a National Learn to Swim Program at several primary schools in The Bahamas and its negotiations with the Ministry of Education and Youth Sports and Culture for an expansion of this program, on behalf of ALL swimming clubs, will extend the reach of swimming in The Bahamas. I am especially pleased of their success at the Thelma Gibson Primary School and Schools in Gambier and Adelaide and expanded plans at the Sandilands Primary School. The Water Survival program also introduced by the YMCA and Swim to Empower, funded by the Bahamas Olympic Association, and has also enabled the Federation to expand water safety and survival knowledge outside of New Providence.

Mancer Roberts was appointed as the Secretary to the Open Water Swimming Technical Committee for CCCAN in 2010 and will be working very closely with the Federation to expand the Open Water Swimming in The Bahamas. The FAC, Conch Man, Abaco and SWIFT programs are very successful and the Federation will be focused on adding Open Water Swimming to our National Championships.

Our Female Relay team that won our FIRST Pan AM Medal, a Bronze in 2007, fell short of our goal to represent The Bahamas at the 20012 Olympic Games, BUT is the highest ranking program in CCCAN. We certainly believe that we have the talent and with continued focus and increased opportunities, and of course, expanded funding; The Bahamas will one day have a relay team at the Olympic Game Level.

Without question, Arianna Vanderpool-Wallace has been an amazing Ambassador for our Sport. She is not only a double and repeat NCAA Champion, but secured our first World Medal at the 2010 World Short Course Championships in Dubai in the 50 meters freestyle. Her performances at the 2012 London Olympic Games, that I had the opportunity to witness, were amazing. She is our first Olympic Finalist in the 50 meter freestyle, and also is our first semi-finalist in the 100 meters freestyle.

The Federation is committed to developing our swimmers beyond CARIFTA/junior level and did provide an opportunity for our female relay team to qualify for the London Olympics. We will start earlier this year and will develop a pool of relay swimmers and will also encourage our male swimmers to duplicate the results of our outstanding females.

Locally, the hosting of the 2012 CARIFTA Games was a success and I must thank the Committee, particularly the hard-working Finance Team, led by Cecile Greene, and all of the core committee members that worked to ensure that these Championships were indeed the best ever. The feedback from all visiting countries is that it will be difficult to duplicate the Bahamas' success and the committee has cemented our reputation as an outstanding organizing committee. A special thanks to our Title Sponsor, BTC, for its support of CARIFTA, and the gifts to the entire team.

We are very proud that we have more Bahamians qualified as International Judging Officials than any other local Federation. Algernon Cargill, Mancer Roberts, and Kathy Dillette, Dr. Susana Campbell, and John Bradley are FINA Officials and Dewey Taylor has been recommended for the 2013-2017 list. Mancer Roberts participated as judging official at the 2010 World Championships, the 2011 Pan American Games and has represented the Bahamas with pride. John Bradley, Mancer Roberts and Algernon Cargill represented The Bahamas at the 2012 Swimming World Conference in Moscow and John and Mancer also participated in the Swimming Coaches conference held prior to the World Swimming Conference in Moscow

Mancer Roberts is commended for his excellent work in leading the team of local judging officials and coordinating all local meets – his contribution in getting all Officials ready for CARIFTA was exceptional.

The declined medal performances at CISC/CCCAN are a direct result of the Bahamas deciding to field smaller teams with only qualified athletes and practically no relays at these championships.

Our goal remains to win the CARIFTA Swimming Championships in both points and medals – we have won in medals during 2006 and 2007 and narrowly lost in the points category. Our Team's performance in 2012 was amazing!



#### **National Championships**

The National Championships continue to grow and the BSF remains grateful to our perennial sponsor, RBC Royal Bank of Canada. 2011 and 2012 Nationals were FINA sanctioned meets for the London Olympic Games and the 2012 Championships was particularly memorable as it was the last qualifier in the Americas and we had several international swimmers competing and qualifying for the Olympic Games. Arianna Vanderpool-Wallace also re-qualified at these Championships.

Swimmers seeking to represent The Bahamas internationally and/or swimmers receiving subventions are required to compete in these championships unless they have received a written exemption from the BSF. The Barracudas Swim Club won the championships in 2009 and 2010, and Swift Swimming won 2011 and 2012.
